We're not responsible for checking that the information provided by J.P. Morgan Personal Investing is correct. Please contact J.P. Morgan Personal Investing if you have any questions about your J.P. Morgan Personal Investing pots or investments.

You'll be able to use the Chase app to make a payment into your J.P. Morgan Personal Investing account. Please see Chase's General Terms and Conditions for more information on how we make payments. You will not be able to make payments directly into any J.P. Morgan Personal Investing pension pots from within the Chase app.

Just so you know, you can only link a J.P. Morgan Personal Investing account in your own name to your Chase account.
